Mode of Delivery

Blended Delivery

10 hours of tutorials will be delivered through synchronised online learning which includes on-campus theory and simulation-based training and simulation-based assessment.

All students are advised to complete Structured Interactive Learning at their own time as a part of self-directed interactive learning which approximates 10 hours of study per week.

The blended mode of deliver with accommodate students all across Australia. Simulation based training (SBT) and simulation-based assessment (SBA) will be conducted on-campus in block. All learning and teaching activities including formative and summative assessments will take place on Canvas as this is IHNA's Learning Management System.

Entry Requirements

While there are no formal entry requirements for this course, applicants should demonstrate the ability to perform tasks required by the industry.

IHNA Admission Requirements

- 16 years of age and above at the time of course commencement.
- Successful completion of an Australian Year 10 qualification or equivalent.

Mature age students (22+) may also be considered without the minimum educational requirements, with each case reviewed individually to assess suitability for the course requirements.

Additional Requirements

Language, Literacy, and Numeracy (LLN) Requirement:

All students are required to undergo the LLN test offered by IHNA to determine their suitability for successful course completion.

Digital literacy

- Basic computer skills covering the most common uses of a computer, including managing computer files, word processing, using spreadsheets and databases; creating presentations; finding information and communicating using computers; and being aware of social and ethical implications of Internet use.
- Having own computer (desktop or laptop) to facilitate the training and assessment. Recommended Laptop requirements: Core i3 Processor, 4 GB of RAM, Operating system; Windows 7 or later version, Screen; 10" or higher, Microsoft Office or Open Office Program, Adobe Reader and Antivirus Program.

Professional Experience Placement requirements

- » A satisfactory National Police Clearance (NCC) or Australian Federal Police (AFP) Clearance certificate
- » Immunisation records
- » Working with Children Check (WWCC)
- » National Disability Insurance Scheme (NDIS) Clearance
- Students must declare a disability or disorder (if any), or if they are on any medication which may require reasonable adjustments.
- Physical requirements that are necessary to pass the course objectives are:
 - 0 **Strength:** To assist with lifting and transferring a client, and perform CPR
 - 0 **Mobility:** To bend, stoop, and bend down to the floor; ability to move around rapidly; and to move in small, confined spaces
 - 0 **Hearing:** To hear through the stethoscope to discriminate sounds; to hear cries for help; to hear alarms on equipment and emergency signals; and various overhead pages
 - 0 **Vision:** To make physical assessments of client and equipment
 - 0 **Communication:** To communicate in both verbal and written formats; and interact with clients, staff, and faculty supervisors

Where a student breaches the above requirements, they could be excluded from their practical placements which may result in unsuccessful completion of the course.
