About the Course

HLT54121 – Diploma of Nursing is a nationally accredited course. This 18-month course delivers the essential nursing skills and knowledge required to be eligible as an Enrolled Nurse with Nursing and Midwifery Board of Australia (NMBA).

The course is provided through Blended & Face to Face mode of delivery. It will be delivered over 1540 hours including theory, self-paced structured e-learning, simulation training.

Job Outcomes

After successful completion of the program the graduates may apply for registration with the Nursing and Midwifery Board of Australia as an Enrolled Nurse. The occupational title is Enrolled Nurse (EN). Upon successful registration with NMBA, graduates may gain employment in various healthcare facilities, which may include:

- Hospitals
- Day respite centres
- Rehabilitation centres
- Residential group homes
- Medical centres
- Training resource centres
- Open employment services
- Other community settings and clients homes

This program follows Competency-based training which is the concept that individuals learn at different paces as well as through different modes and different environments and that the skills and knowledge that a student has acquired previously are able to be formally recognised.

Mode of Delivery

Blended Delivery

20 contact hours per week will be delivered through synchronised Online learning which includes on- campus simulation based training and Professional experience placement.

Besides the above structured learning, students are advised that they will be required to do approximate 10 hours per week of unstructured learning.

The blended delivery mode is only available to domestic students on selected campuses and subject to eligibility.

Students must meet additional requirements for Professional Experience Placements as required such as a clear police check, working with children check & immunisations.

Face to Face Mode Delivery

20 contact hours per week will be delivered through on-campus class, Online learning, simulation based training and Professional experience placement.

Besides the above structured learning, students are advised that they will be required to do approximate 10 hours per week of unstructured learning.

Students must meet additional requirements for Professional Experience Placements as required such as a clear police check, working with children check & immunisations.

Entry Requirements

There are no prerequisites or any other training package entry requirements for this course. IHNA's admission requirements for the course are as follows.

- Successful completion of year 12 or pathway through certificate III & IV level qualification from HLT or CHC training package (Domestic students)
- 18 years of age and above at the time of commencement of the course
- Successful completion of the language, literary and numeracy (LLN) test and demonstration of competence level as exit level 3 in the Australian Core Skills Framework (ACSF) in both reading and numeracy
- NMBA specified level of English language skills¹
- Basic computer literacy skills²

*Mature age students (22+) may also be considered without the minimum educational requirements. Each case will be reviewed individually to ascertain the student's suitability for course requirements.

Professional Experience Placement (PEP) requirements

- A valid and current National Police Clearance (NPC) or Australian Federal Police (AFP) Clearance certificate
- Required immunisation
- Working with Children Check (WWCC)
- A valid NDIS Worker Screening Check
- For safety reasons, students will only be permitted to attend placement until they are 32 weeks pregnant. A fit to work certificate may be required for students attending placements when pregnant.
- IHNA is obligated to notify to AHPRA when we have a 'reasonable belief' that a student has an impairment that, when undertaking clinical training, may place the public at substantial risk of harm (a very high threshold for reporting risk of harm to the public). Students are hence required to declare any disability or disorder (if any), or if they are on any medication which may require reasonable adjustments.³

Where a student breaches the above requirements, they could be excluded from their practical placements which may result in unsuccessful completion of the course.

Fees & Funding

Full Fee: \$27,000

State Funding

Victoria: If the student is eligible, for funding non concession fees student pays: \$11,600.00*#

Western Australia: If the student is eligible for funding, student pays \$0#

New South Wales: Funding available for eligible students
